The nominated adjudicator must be approved by two-thirds majority vote of that district's membership (total number of district members, not just those present) for the nomination to be moved forward to the FOA Executive Board. The district vote shall be by secret ballot.

6. The Executive Board may approve the district's recommendation by two-thirds majority vote of the Executive Board (total number of Executive Board members, not just those present) to be eligible to attend the Approved FOA Adjudicator training. Voting will be done by roll call.

**NOTE:** Any FOA member is allowed to audit the FOA Adjudication Training, as long as registration and fees are paid. **Auditing does not give approval status.**
